ANNUAL QUALITY REPORT 2023-2024



Every member of UBT's academic community is actively engaged in the quality assurance process within the faculty. This collective involvement is essential for fostering a culture of continuous quality improvement and accountability within all spheres of academic operations.

At the Faculty level, the Quality Sub-Committe is responsible for performing all the work related to quality assurance within the faculty and the regular monitoring and process of teaching and learning inside the Faculty of Management, Business and Economics. The MBE Faculty has a designated Quality Assurance Sub-Committee on a program level with a Quality Assurance Officer for each branch that works in full harmonization with UBT Quality Assurance Committee and Quality Manager.

The aim of the MBE Quality Assurance Sub-Committee is to provide excellence in performance by discussing annual work programmes focusing on the goals and the quality improvement measures, discussing business reports focusing on reports on quality, discussing approaches towards periodical detailed self-evaluations and external evaluations, discussing results of evaluations and proposed measures for improvement, discussing effects of individual quality assurance mechanisms and proposing improvement measures, reporting to the Faculty Council on quality achievements, proposing improvement measures for adoption on both decision making bodies, monitoring implementation of student questionnaires and proposing improvement measures for their use. All this work is done with the aim of continuous improvement in the Faculty with the aim of providing the best possible environment for lecturers and students and creating a healthy learning ecosystem at the Faculty of Management, Business and Economics.



Evaluation by students represents a very important indicator for measuring the quality performance in the Faculty. The Faculty of Management, Business and Economics has defined the threshold of 4.25 (out of 5) as a satisfactory level, which represents satisfaction at the level of 85%. Every part evaluated less than that, is looked at carefully with the aim of finding the indicators that have sent to that state and then identifying the opportunities for improvement by giving the relevant recommendations.

General Summary Internship success rate

Regarding the student's success rate in completing their intership on their first attempt, as seen above, 96% of them succeed in doing that. The overall evaluation comes from the evaluation that comes from their mentor (a professor in MBE program) and the certificate they gain from the company they undergo their intership in, specifically under the supervision of a supervisor from the respective company.

Overall, all students who attend an intership program, succeed and the overall success rate from internship is 100%. However, on their first attempt, some students for personal students may not be able to achieve all the criteria to be considered to have completed the internship, but after the extension that can be offered with the cooperation of the faculty with the company, the students manage to complete the internship in the next attempt.

Information regarding students' involvement in research activities and international projects for the 2023/2024 academic year

During this academic year there has been greater interest among students to be involved in international projects, in joint lectures with foreign partner universities and exchanges as a great way to create networking with their international peers. A portion of the number presented in the table below belongs to the students included in the Erasmus+ Coweb project, where some students have been trained in Dresden, Germany to become e-tutors and now they contribute to this project with working groups in which students from MBE program participate. Also, a part of the total number included in the first indicator in the table belongs to students who attended joint lectures with IOWA University.

The indicators that measure the student satisfaction rate, dropout rate and graduate employment rate as seen above, are similar for all branches. Regarding the student/staff ration which is higher in Prishtina branch, this comes from the fact that in Prishtina the quota for students is higher meaning more students are enrolled (which are however divided into many groups).
